Our Esteemed Executive Officer Jesse Turley is doing his part again with regard to our presence at the Louisville Sport Boat and Recreation Show.

Jesse scheduled a lunch with Kim Muncy, Director of the Louisville and Nashville Boat Shows for the National Marine Manufacturers Association (NMMA). Jesse and I met with "Sweet Kim", as Jesse calls her, this past Wednesday at Audubon Country Club over lunch. The purpose was to thank her for our 2020 Boat Show booth, and to discuss possibilities for the 2021 Boat Show.

2020 Boat Show- Kim Muncy reported that she and her NMMA staff were very pleased with the look, feel, and attendance at our booth. She thought that the larger booth and central location contributed to our success. She was happy to play a part in our public boating education effort. From our perspective, our booth was an outstanding success by every measure. More members participated in staffing the booth than in any recent year. We had more interaction with the boating public than in the past and ended up with more qualified prospects for classes and membership. We conducted a total of 19 Mini-Seminars on Anchoring and Weather to a total audience of several hundred people. Ultimately we had more attendance at our ABC Classes than we have had in recent years and added several new members. 5 of these new members passed both our ABC Course and Seamanship.

2021 Boat Show- Kim tells us that NMMA is going ahead with plans for a Louisville Show again this coming January. They are forwarding a proposal to the Governor's office detailing plans to meet all existing COVID-19 regulations. Kim would like to have us back with the same type of booth we had last year. After telling her of our plans to invite the LMPD River patrol to join us with some mini presentations, she was very excited and suggested the possibility of also including KY Fish and Wildlife. She even mentioned enlarging our space in order to be able to social distance with a audience of 20.

So, there is still much uncertainty surrounding a Louisville Boat Show in 2021. But if there is one, as it stands right now, America's Boating Club Louisville will be there again this year with a prominent location. All this is thanks to the effort Jesse Turley made in last year in expanding our relationship with the staff at the Louisville Boat Show.

Now on another note. Jesse will be out of circulation for a couple months. He will be entering Baptist Hospital on Friday, October 17th, for another procedure on his knee. This time he will be in a non-weight bearing situation for 4-6 weeks in a Rehab Facility on Herr Lane, followed by another knee replacement. Once he gets settled, I will forward his address for get-well cards and COVID allowed visits. In the meantime, please keep Jesse in your prayers for a speedy recovery.
